Minutes of last Meeting	Approved	
Vice-Chair	Only one expression of interest – TM – comm approves appointment	
Financial and Membership	Current balance - £5948.49	
Update	5 members outstanding 4x £2000 1x500 Chased – 3 immediate responses, one yet to respond, 1 unresponsive for some time LexisNexis – do not wish to be members	
Liaison Officer Update	DCMS update sent – keeps them engaged  Meeting with UKIFA last month – they see ADVP as org to work with – main goals helping public as information resource – no plans to share intel other than general trends – follow up meeting planned	
Immigration Sub-Group	TM – main focus has been meeting with Home office reps – no clarity where issue with sight of physical docs will go – chip opening key to remote checks – 21st June date could move if restrictions are not lifted – best outcome would be delay of physical doc check KH – Home Office end game is for all non-UK nationals to evidence RTW via a share code process by 2024  Employers who employ EEA nationals from 01-01-21 to 30-06-21 will have indefinite statutory excuse regardless when EEA national entered the UK  Any EEA employee found without EU Settlement scheme will have until end of 2021 to apply – employers will be expected to dismiss employees who will not apply to EUSS	
Intelligence Sharing	Amberhill – 9 members involved – TM/AG spoken To Amberhill – who are exploring the possibility of supplying a time limited set of data for value evaluation – not yet able to get Intel Sharing Unit to authorise sharing of data – looking at single hosted ADVP solution long term  NDFU – discussions on what can be shared – update disappointing – belief a forum would be a good way of moving forward  TM suggest ADVP produce a white paper listing benefits of intel sharing  TM/AG to discuss further offline to develop framework	
Standards Sub-Group	JJ - Agreed at last meeting to pause TM – no response to feedback on GPG45 received – can we chase	
Digital Identity Sub-Group	JJ – DCMS Trust Framework – GDS concept of single sign on for all gov services would have varying levels of ID verification depending on service – would exist in parallel to trust framework – little detail or clarity available now looks like this is for private sector and GDS will have separate plan for gov services EU announced last week EU Digital Identity Scheme – overarching framework sitting over national identity schemes
