Liaison Officer Update	AG circulated complaints mapping process from DCMS ref IDSPs – CBs advise they do not have time to address complaints – DCMS keen to get complaints process sorted out SS advised they do not have a proper handle on what a compliant is More concerned with incident management and data breaches TM requests AG circulate the 4 points discussed for comm members to raise at future DCMS engagement meetings Website/social media no update, hope to get it sorted soon – TM thinks there is urgency around website update as this will be viewed by prospective members Two papers shared with Home Office – one on share code imposters and one on feedback on digital scheme so far DCMS has split working group in two

IDSP/share code update	meeting, interested in intelligence – Trust ID has volunteered to be guinea pig for Home Office IDSPs getting share codes TM has written to Home Office to request clarification on this, some IDSPs claiming to give statutory excuse, AG has circulated response from Home Office, clarification was required HO confirm members are IDSPs for RTW checks Also confirmed that IDSP can only give statutory excuse for digital identity checks AntonZ to provide comment, and decision will be made what to send in response to the Home Office TM proposes sending all three discussed comments

of Certification and Assurance, DCMS	Certification scheme allows for flexibility to add elements to baseline – modularity allows for extension of scope TM raises challenge where DBS will now accept out of date passports via IDSP, however RTW does not, impact on IDSPs, GPG45 needs to be updated AntonZ asks if there will be details of upcoming schemes to ensure providers have time to make necessary changes prior to go live	
АОВ	TM raises membership, he believes ADVP is growing in stature and raises question why with 32 certified IDSPs we do not attract more members Questions whether OIX is getting membership, cites Trust ID and others are members of OIX – suggests maybe joint membership, poss speak to Nick Mothershaw Ayal leaving AU10TIX
