Liaison Officer Update	Amberhill – seen it 'wither' however Home Office now doing discovery to establish if it is still a strategic fit – conclusion there is a strategic fit for a renewed service – unclear who will own in future – currently Met Police Gary Miles had been scheduled to appear at last meeting – he was involved in major cyber crime operation CIFAS undertaking a research project to look at use of AI to generate ID documents to be used for fraud
Trust Framework Share code certificates and passports within GPG45 Government wallet GDPR Any other framework updates	Share code certificates and passports not treated the same in GPG45 BRP cards being retired – eVisa from end of year – DC states share code certificate should have same weight of evidence as passport KH advises not all share code certificates hold image of the holder – meaning likeness comparison cannot be done DC suggests collating a set of questions to submit to Home Office Gov Wallet Civil service looking at creating a government wallet – may disrupt market GDPR See below DSIT are planning to issue revised version of the framework – no details on how this will impact certified IDSPs based on when they are certified – recognised as an issue
